Consumers also visited multiple pumpkin patch venues surrounding the Omaha area. The consumers explored many attractions within the venues including corn mazes and haunted houses.



December marks the last month for employees to finish their annual required training. We use a third-party system called Relias as a host for most of our required training. Relias also has a ton of other pieces of training which are elective options. I tell you this because training is an active and important piece of what Vodec provides its employees.

Additional to Relias required and optional training for supervisors, managers and directors is our monthly Vodec University sessions. For most of these we bring in outside subject matter experts on a variety of topics to support how we do our business. We also work on our financial literacy with open book discussions about financial reports. Our belief is that if employees know more about the financial status, then there will be better fiscal decisions made. We want to squeeze every drop of value from every penny we receive.

Trainings through Relias and trainings through other resources are ways Vodec continues to ensure the integrity of service provision and program administration.
